## NOTICE OF GENERAL MEETING:

### *Deep Roots and New Beginnings*

We are very excited about this year's first General Meeting on Wednesday, September 28, 4:00 p.m. at St Martin's Anglican Church. All members are encouraged to attend.

This year we will celebrate the past, present, and future of our union with our theme of *Deep Roots and New Beginning*. All the presidents who have held the office since this year's president, Martin Stuible, started teaching in 1990 have been invited. So far, seven out of eight have indicated that they will join us on September 28. #### Motions for consideration at the General Meeting

1. That the NVTA fee for the 2016/2017 school year be set at 0.80% of a teacher salary.
2. That the 2<sup>nd</sup> Vice President be released at 0.6 FTE for the 2016/2017 school year.
3. That the Professional Development Chair be released at 0.4 FTE for the 2016/2017 school year.
4. That each Executive Committee member and Standing Committee Chairperson who attends the Summer Planning Session be compensated the equivalent of one day at the current TIOC rate (excluding the President, First Vice President, and Second Vice President).
5. That the proposed budget 2016/2017 be recommended to the General Meeting in September.
6. That the proposed NVTA Goals & Priorities for 2016-2017 be recommended to the General Meeting in September.
7. That the NVTA Executive recommends to the NVTA General Meeting that the NVTA Executive Committee Compensation Policy 2016-2017 be adopted.
8. That the Representative Assembly recommend to the General Meeting that the CSR Compensation Policy be adopted, as determined by the Rep Assembly.

## KEEP CALM AND TEACH ON

This fall teachers across British Columbia will embark on an unprecedented process of beginning to implement new curriculum across all subject areas from Kindergarten to Grade 9. In many ways, with its focus on deeper understanding and critical thinking, this new curriculum is simply catching up to what teachers have already been doing in the classroom. Many teachers are feeling stress and anxiety about trying to implement such a wide ranging change at the same time as meeting many and varied needs of students in the classroom and other demands in a school.

The BCTF, Ministry of Education, BC Principals' and Vice-Principals' Association, and the BC School Superintendents Association address this important issue in a joint document stating:

*It is therefore critical and cannot be overemphasized that the implementation of the curricula be viewed as an ongoing, long-term process, rather than an event. With this in mind, we understand it will take time for teachers as they begin implementing the redesigned K-9 curriculum in September 2016. Rather, curriculum implementation is an ongoing process built around cumulative, reflective practice supported by all learning partners.*

With this statement in mind, teachers should view the process of implementing the new curriculum as beginning now and continuing throughout the year and beyond. Additionally, teachers do not need to recreate every activity, worksheet, assignment and test for the new curriculum. As teachers work with the new curriculum, they should review current materials and assess what materials will still work, which materials can be adapted to fit and which materials no longer work. There is no need to create all new materials and lessons for the new curriculum.

Another important issue to keep in mind is that this new curriculum is just that – curriculum! Curriculum informs teachers about what subjects and topics to cover at each grade. Teachers still have professional autonomy over how to teach that curriculum – pedagogy! Although the new curriculum is designed to better support inquiry based instruction or project based learning, it does not require any specific type of instruction. Teachers will continue to make decisions about the best way to teach the new curriculum to students.

The pace of implementation of the new curriculum will vary from teacher to teacher, just as the pace of learning varies from student to student. If a particular school has a group of teachers who are at a certain point in implementation, it does not mean that other teachers must also be at that point or change how they are planning their instruction. Just as with the previous curriculum, teachers who teach the same grade or subject area may be at different points or approaching the curriculum in different ways.

The new curriculum provides an exciting opportunity for teachers to continue to expand on many of the recent changes we have seen in teaching and helping students to a more meaningful understanding of the world around them. It was designed by teams that included teachers from across the province, including North Vancouver, appointed by the BCTF. The NVTA wants to ensure that each teacher has the support necessary to successfully implement the new curriculum at their own pace!
