IMPORTANT YEAR-END PRO D INFORMATION

CONTRACT TTOC POSITIONS 2021-2022

In the coming year, there will be 9.0 FTE Contract TTOC positions. These positions are part of a mediated settlement, and are different from District-On-Call positions. A Contract TTOC will be on-call for the entire school year. As they are on contract, they will receive benefits and sick days and be paid fully on scale.

These positions will be posted no later than August 2, 2021. If you are currently in an assignment and are interested in being a Contract TTOC, you would need to be unplaced in early August to apply. This means that you will either need to have been surplussed from your school, or apply for a committed transfer by May 31.

BCTF Telephone Town Hall on Changes to Local Bargaining Wednesday, May 19, 5 – 6:30 pm

The BCTF emailed all members last week, with details about potential changes to local bargaining. Information about these potential changes is available on the BCTF Portal. **The BCTF is holding a Telephone Town Hall for members within the Lower Mainland and Fraser Valley region on May 19 from 5:00 – 6:30 pm.** The NVTA Rep Assembly on May 19 will exceptionally end at 5 pm and not 6 pm, to ensure that members can call in.

When the town hall is about to start, you'll get a call from the automated system to join in. If you don't receive a call, you can dial in directly by calling 877-229-8493 and using the ID code 119463. The town halls will be recorded and posted on the BCTF Portal later in the week, but if you join live, you will have a chance to ask BCTF President, Teri Mooring, and representatives of the Bargaining Team your specific questions. The ratification vote for these changes will be held May 25-27.
