LOCAL REMEDY OPTION #4

The NVTA and the NVSD have renewed their agreement to provide individual teachers with an additional option for use of their unaccessed remedy minutes from the past five school years ending June 30, 2022.

In addition to the maintained provincial options for use of remedy minutes, individual teachers may elect a fourth option to convert some or all of their accumulated minutes to a dollar amount, using the provincially agreed-to formula. This dollar amount will then be used explicitly for the purpose of professional development opportunities.

All requests for Professional Development will align with the NVTA Professional Development Policy.

Related costs associated with the teacher accessing this additional professional development, as outlined below, will be deducted from their remedy balance owing.

• Registration for workshops, conferences, lectures etc.

• Cost of the TTOC to cover the release should the Professional Development activity occur on an instructional day

• Accommodation, meals, and travel expenses as per the NVTA Professional Development Policy; receipts required.

Teachers requesting a leave of absence to participate in a Professional Development activity must have their applications into the NVTA four weeks prior to the first release day required.

The letter of agreement expires on June 30, 2023.

The new application form to convert remedy minutes to a dollar amount is available on Forms central, under School services (1300-99-05).


